

**In the Court of the Judicial Magistrate, F. C., Deoni, Tal-Deoni, Dist-
Latur.**

: C H A R G E :

I, Atish Pralhad Khollam, Judicial Magistrate, F. C. at Deoni, Dist-Latur, do hereby charge you :

1. **Jijabai Dattu Ashokwad,**
Age- 85 yrs,
2. **Subhash Dattu Ashokwad,**
Age-45 yrs,
3. **Shalika Dattu Ashokwad,**
Age-40 yrs,
R/o. Ajani , Tal. Deoni, Dist. Latur.

As follows :

That, on 10.08.2022, at 13-00 Hrs., at mauje Ajani Shiwar agriculture land, in survey No.35/C, Ajani, Dist. Latur, you accused Nos.1 to 3, in furtherance of your common intention, committed trespass in the agricultural field of the informant and thereby committed an offence punishable under section **447 r/w.34** of the Indian Penal Code and within my cognizance.

Secondly, you accused, on the above said date, time and place, knowing that by an order promulgated by Collector, Latur, where under you were directed to stay manufacture or use of Nylon String (नायलॉन मांजा), you accused disobeyed such direction, and thereby committed an offence of theft punishable under section **188** of the Indian Penal Code, 1860 and within my cognizance.

Thirdly, on the above said date, time and place, you accused in furtherance of your common intention, voluntarily caused hurt to informant and thereby committed an offence punishable under Section **323 r/w 34** of the Indian Penal Code and within my cognizance.

Fourthly, you accused Nos.2 to 8 along with deceased accused No.1, on the above said date, time and place, in furtherance of your common intention, insulted the informant and witness and thereby gave them provocation, intending that such provocation would cause them to break public peace and thereby committed an offence punishable under section **504 r/w.34** of the Indian Penal Code and within my cognizance.

Lastly, you accused Nos.2 to 8 along with deceased accused No.1, on the above said date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening to kill the informant and witness thereby committed an offence punishable under section **506 r/w.34** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on that charge.
