I, Atish Pralhad Kholam, Judicial Magistrate, F.C. At Deoni, Dist-Latur, do hereby charge you :

as follows :

That, you accused No. 1 to 9 in conflict with law, on 29.05.2022 at about 00.30 hours at Yenki Tal. Deoni, Dist. Latur in prosecution of your common object, voluntarily caused hurt to informant **Rajabai Govind Kamble** for the purpose of extorting from the said informant a property, namely, gold ornaments worth Rs.30,000/- and thereby committed an offence punishable under section **327 r/w. 149** of India Penal Code and within my cognizance.

That, you accused No. 1 to 9 on the above said date, time and place, in prosecution of your common object, committed house trespass by entering into the house of informant **Rajabai Govind Kamble** and witnesses, having made preparations for causing hurt (or assaulting or wrongfully restraining) to the informant or to put her in fear of hurt or of assault or of wrongful restraint and you have thereby committed an offence punishable under section **452 r/w. 149** of India Penal Code and within my cognizance.

That, you accused No. 1 to 9 on the above said date, time and place, in prosecution of your common object, assaulted or used criminal force to the informant **Rajabai Govind Kamble** and witnesses intending to outrage or knowing it to be likely that you would thereby outrage her modesty and thereby committed an offence punishable **u/Sec.354 r/w. 149** of the Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, were a member of an unlawful assembly and in prosecution of the common object of the said assembly was to assault informant and witnesses, committed an offence of rioting and thereby committed an offence punishable under **Sec. 147** of Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, were a member of an unlawful assembly and were at the said time armed with a deadly weapon i.e. stone and wooden sticks and thereby committed an offence punishable under **Sec.148** of Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, in prosecution of your common object, by throwing stone acted so rashly or negligently as to endanger human life, or the personal safety of others, and that you have thereby committed an offence punishable under section **336 r/w. 149** of the Indian Penal Code, and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, in prosecution of your common object, uttered obscene words in public place and that such uttering was obscene and that it caused annoyance to informant and witnesses and thereby you have committed an offence punishable under section **294 r/w. 149** of the Indian Penal Code, 1860 and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, in prosecution of your common object, voluntarily caused hurt to informant and witnesses and thereby committed an offence punishable under Section **323 r/w. 149** of the Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, in prosecution of your common object, intentionally insulted the informant and witnesses and thereby gave her provocation intending that such provocation would cause her to break public peace and thereby committed an offence punishable under Section **504 r/w. 149** of Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, in prosecution of your common object, committed criminal intimidation by threatening to kill the informant and witnesses and

thereby committed an offence punishable under section 506 r/w.149 of Indian Penal Code and within my cognizance.

That, you accused No. 1 to 9, on the above said date, time and place, formed an unlawful assembly, in contravention of the order of District Magistrate, Latur and thereby committed an offence punishable under section 135 of Bombay Police Act and within my cognizance.

And I hereby direct that you be tried by this Court on that charge.
