

Resumed on S. A.Cross examination by Ld. Advocate Anaokar for first party -

11. I can read and write English language to some extent. Now I say that, I cannot read the affidavit drafted in English language. I have studied upto 5th Std. I have not filed any document to prove the contents of para no.2 and 3 of my affidavit. It is true to say that, the Aparklene Fabrics is owned by Mr. Kishor Baldia. I am not aware whether the present case includes the name of Mr. Kishor Baldia as a party. It is true to say that, the address mentioned in para no.3 i.e. Office No.14/15, Kalbadevi, Mumbai is of Aparklene Fabrics. It is true to say that, the godown at Dharam Complex, Bhiwandi, Thane is also of Aparklene Fabrics. It is not true to say that, the Aparklene Fabrics given me the contract of clipping work. It is not true to say that, there were 2 to 4 workers working under me to complete the work given by Aparklene Fabrics. It is not true to say that, I was raising bills to the Aparklene Fabrics.

12. Now I am shown the document at Exh.U-16, page no.16. It contains my name. It is a copy of blank copy of cash voucher. It is not true to say that, it belongs to my company. It is not true to say that, I used to give such type of vouchers to Aparklene Fabrics. I have not filed any document to show that, the first party was paying salary in cash. I have not filed any document to show that I was working with the first party M/s. Sun Silk Mills. I have not filed any document to show that, the second party demanded to increase his salary as mentioned in

para no.4 of my affidavit. I have not filed any document to prove the contents of para no.5 of my affidavit. It is true to say that, I have deposed falsely in para no.6 that the first party was running the companies namely Sun Silk Mills, Aparklene Fabrics, Shubh Textiles and Laxman N. Galpelli in my name.

13. It is not true to say that, Pappu, Uma Ray, Devendra Yadav and Sanjay Sah were not working with Sun Silk Mills. I have not filed any document to show that these workmen were working with Sun Silk Mills. I am not aware whether there was contract between Ramesh Nalla and Sun Silk Mills. It is not true to say that, only Ganesh Kunchan and Umesh Prasad were working with the first party. I have not filed any document to show that, I was making payment to the persons namely Kalpana Rathod, Ganesh Kunchan, Pappu, Uma Ray, Umesh Prasad, Vijaya, Ramesh Nalla, Devendra Ydav and Sanjay Sah, as mentioned in para no.6 of my affidavit.

14. I do not know whether Asst. Commissioner of Labour has taken any action against the first party. Now I say that, I am not aware about the incident mentioned in para no.7 of my affidavit. I am not aware about the facts mentioned in para no.8 of my affidavit. I am not aware about the case of second party workman. It is not true to say that, there was no any kind of relations between me and the first party company.
