ORDER BELOW EXH. U-11

(Passed on : 31/10/2025)

The present application is filed by applicant’s legal heirs
for amendment in the application.

Brief facts of the application is as under :

2. According to the applicant’s legal heir, Late Vinod Namdev
Salunkhe was in services of the opponent during the period from

April, 2006 to December, 2017. At the time of filing of the application, applicant Smt. Vaishali Vinod Salunkhe not disclosed details about their children namely Kum. Priyanka Vinod Salunkhe and Kum. Prasad Vinod Salunkhe. Due to the same, they are not came on record as legal heirs of Late Vinod Namdev Salunkhe.

3. During the pendency of said application, Smt. Vaishali Vinod Salunkhe left the house of Late Vinod Namdev Salunkhe. Both children are reside with the brother of Late Vinod Namdev Salunkhe. Hence, the present application is filed by Shri. Vishal Vinod Salunkhe on behalf of minor daughter and son of Late Vinod Namdev Salunkhe. Hence, the legal heirs be taken on record by impeding them as party by further permitting them to make necessary amendments in this regard in the cause title of the main proceeding. Therefore, requested to allow the application.

4. The opponent no. 1 has resisted the application by filing say at Exh. C-13. The original applicant is not interest in pursuing the present application. The original applicant had neither made any other legal heirs of the deceased Vinod Namdev Salunkhe nor made any pleading in the application to that effect.

5. Vishal Namdev Salunkhe is not party to the original application. Therefore, he cannot file an application for amendment of the pleadings. The original applicant of application is not deceased and therefore, her alleged legal heirs cannot be bought on record. Therefore, requested to reject the application.

6. Heard both sides. Perused the application and say. Went through the record. In case proposed amendment is allowed, no

prejudice will be caused to the other side as the proposed legal heirs by way of proposed amendment try to bring the certain facts on record. To decide the real controversy between the parties amendment is justified. Being the legal heirs of the applicant, they are necessary party in whose absence matter cannot be adjudicate finally. Therefore, the application deserves to be allowed. Hence, I pass the following order :

ORDER

1. The application Exh. U-11 is allowed.
2. The applicants are directed to carry out the amendment in main application on or before next date and supply the amended copies of the same on record.
