1. I have filed evidence affidavit before this Court. The contents of the same are true and correct. It bears my signature.

**Cross-examination of Applicant Shri. Bhagwan Autade by Adv. Shri D. D. Nikam for Opponent :**

2. I am 10<sup>th</sup> failed. I am working as a daily wager. I know in this matter FIR was register against me. It is true that, initially session court rejected my anticipatory bail application. It is not true to say that, I have taken contract to dig & construct the well. It is not true to say that, I was absconded for two months after anticipatory bail application was rejected. It is true to say that, after two months I had again file bail application before session court. I do not know the contents of my bail application are true or not. It is not true to say that, I have licensed to carry explosive substance. I do not know whether bail application was prepared by my advocate as per his wishesh. I have not received any notice from opponent advocate. I had replied to the said notice through Adv. Haral. It is true that said notice bears my signature as well as my advocate. I have not received any notice from this court. It is not true to say that report bears my signature. I have filed that report before this court in matter WCA C 24/2017. Witness now said that, no copy of report found in court record. It is true that previous Advocate file this matter therefore I do not know about this matter. It is true that from 2016 to 2022 session case was adjudicated before court & each & every date I was present in that matter. I am very well aware that if notice from the court will

received then I have an obligation to appear in the case before court. Present application bears my signature but original acknowledgement in WCA application 24/2017 not bears my signature. The original acknowledgement having address, Bhokangaon, Tal Kannad Dist. Aurangabad. It has not mentioned Bhokardhan. Witness now said that acknowledgment bears my signature. It is true that I am not aware about the present matter. My previous advocate filed this case then I deposed before this court.

It is true that I have resided beside the village of opponent. I do not know opponent have small kids. It is true that, I am aware about the Judgment & Order passed by this Court in WCA 24/2017. It is not true to say that I have carried out business of digging & construction of well. It is true that, there is specific tractor for blasting. It has its own RC number on the date of incidence, I was owner of blasting tractor. It is not true to say that, blasting tractor. It is not true to say that, I have taken permission from Government to carry out explosive substances for blasting purpose. I have not financial capacity to pay amount of compensation to applicant. I have no agricultural land. I have admitted if document relating to agricultural land filed before this court. I can not say whether I have filed false case, false affidavit & deposing false before this court.
