ORDER

1) The Petitioner filed this petition has been filed to defreeze the bank account of the petitioner which has been freezed in pursuant to the registration of CSR.No.1349/2026 of City Cyber crime police station, Coimbatore. It is submitted that the respondent police frozen the petitioner's bank account no.120029238310 of Canara Bank, Nellore Dargamitta branch. Hence, he prayed to De-freeze the account of the petitioner.

2) After receipt of notice the respondent police and APP had failed any reply in respect of this application and no representation was made either respondent police and prosecution side. Sufficient time given to the respondent police but they failed to submit reply. Hence this petition is considered on merits and this court pronounced order. Hence, considering the facts and circumstances of the case and also the petitioner is also ready to deposit the defacto-complainant amount before this court on any condition and this petition is allowed with the following conditions;

(i) The petitioner is directed to deposit a sum of Rs.50,000/- in the form of fixed deposit in favour of CSR.No.1349/2026, City Cyber Crime PS on the file of the respondent and on such deposit, the respondent police is directed to permit the petitioner to operate account by defreeze the Accout No.120029238310, IFSC Code : CNRB0013462, Branch Name:Nellore Dargamitta, Brahmanandapuram.

(ii) The petitioner is directed to co-operate the investigation officer whenever necessary till the filing of final report.

3) In the result, the petition is allowed on merits. No cost.
