APPLICATION FOR PREPARING OF SECONDARY
BRIEF IN THE MATTER

1. We state that, by way of a Miscellaneous Application dated 9th March 2026 ("Application"), the Applicant submitted, *inter alia*, that the Applicant had been defrauded of an amount of INR 1,14,53,960/- (Indian Rupees One Crore Fourteen Lakhs Fifty-Three Thousand Nine Hundred and Sixty Only). It was further revealed that, during the course of investigation, the local police froze/seized several bank accounts into which it was discovered that the Applicant's funds, aggregating to INR 50,12,833.59/- (Indian Rupees Fifty Lakhs Twelve Thousand Eight Hundred Thirty-Three and Fifty-Nine Paise), had been remitted. Accordingly, the Applicant sought reliefs from this Hon'ble Court, *inter alia*, for recovery of the Applicant's aforesaid property from the said seized/frozen bank accounts.
2. The aforesaid Application was filed before this Hon'ble Court on 20th March 2026. A screenshot evidencing the

filing of the matter from the e-Courts website is annexed hereto as Exhibit "A".

3. Thereafter, the matter was mentioned before this Hon'ble Court on 25th March 2026, pursuant to which this Hon'ble Court was pleased to direct that the matter be listed on 28th April 2026 for directions.

4. However, on 28th April 2026, we discovered that the matter was not reflected on the board and had not been listed before this Hon'ble Court. Accordingly, upon inquiry, we were informed that although the scanned version of the Application is available on the Hon'ble Court's online portal, the physical brief submitted before the Registry of this Hon'ble Court, including the original Application, has been misplaced and is presently untraceable from the records.

5. In the circumstances aforesaid, the Applicant humbly prays that this Hon'ble Court may be pleased to:

- a) permit the preparation and reconstruction of a secondary brief in the matter on the basis of a copy of the original Application;
- and

b) grant such further and other reliefs as this
Hon'ble Court may deem fit and proper in
the facts and circumstances of the present
case and in the interest of justice.
