JUDGEMENT

(Delivered on : 06.04.2022)

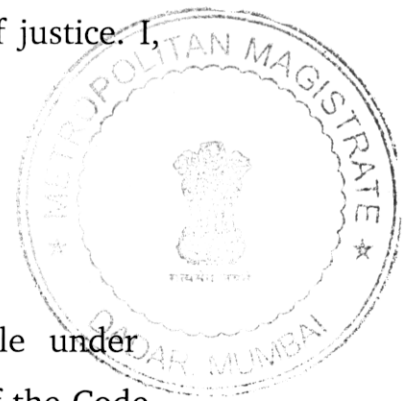
The case of the prosecution is, on 23/12/2021 at about 00.15 AM at Study Lane, Sudam Kalu Ahire Marg, Worli the incident of theft of steel cover took place. So, the informant Sandeep Bhikaji Bugade lodged the report. On the basis of report crime no. 1047/2021 came to be registered. The investigating officer, after due investigation filed the final report vide the stated offence.

2 I framed the charge against accused no. 1 (Exh. 3). He pleaded guilt.

3 I considered plea of the accused, it appears to be voluntarily. Therefore, I accept it. The accused prayed for leniency. Considering the facts and circumstances, following order will meet the ends of justice. I, therefore, pass following order;

ORDER

- 1) Accused no. 1 is convicted for the offence punishable under Section 379 of the Indian Penal Code vide Section 241 of the Code of Criminal Procedure and he is sentenced to suffer rigorous imprisonment for four months.
- 2) He is arrested on 24/12/2021, thus he is entitled to get set off vide Section 428 of the Code of Criminal Procedure.



3) Record and Proceedings be preserved for trial of accused no. 2.
