

ORDER BELOW APPLICATION EXH.08 IN C. C. NO.453/PW/2026

This application is received from the accused through the Jailor, Talaja Central Prison, Navi Mumbai. By way of this application, the applicant/accused No.1 Jahid Ali Rojan Ali Qureshi @ Java Murgi requested to release him on P. R. Bond. It is to be noted that, the application is written in Hindi language under the caption "C. R. No.37/2026 मे आप द्वारा दी गई बेल मे टाईम बाउन्ड मांगने बाबत" . After reading the title of the application it was my perception that the applicant/accused intended to seek the relief of expedite of trial. However, by filing pursis on record at Exh.9 the learned Assistant Legal Aid Defence Counsel intimated that the applicant/accused intended to seek P. R. Bond.

2. Perused the application and say of the Learned A. P. P. I have heard the learned Assistant Legal Aid Defence Counsel representing the applicant/accused and the learned A. P. P.

3. The record shows that, the applicant/accused is ordered to be released on bail on his executing P. B. and S. B. of Rs.10,000/- on 13/03/2026. However, he could not furnish the bail. The applicant/accused is alleged to have been committed offence punishable under Section 305(a) and 317(2) of the B. N. S.

4. The application is opposed by the learned A. P. P. on the ground of seriousness of the offence. It is submitted that, there is no ground exist to release the applicant/accused merely on P. R. Bond.

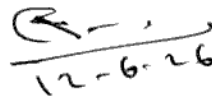
5. Admittedly, applicant/accused has been arrested on 10/02/2026 and since then he is behind bar. The learned legal aid defence counsel submitted that, due to poor financial position, the family members of the applicant/accused could not arrange money to release

the applicant/accused. It is submitted that there is no role attributed by the applicant/accused in alleged offence. It is submitted that if the applicant/accused is released on P. R. Bond he will make necessary arrangement to arrange solvent surety or deposit the cash bail within four weeks.

6. Hence, considering the nature of alleged offence, role attributed by the applicant/accused and also considering the facts and circumstances, I am of the opinion that there is no legal impediment to release the applicant/accused on P. R. Bond as prayed for. Hence, I pass the following order : -

ORDER

- (i) The application is allowed.
- (ii) The applicant/accused No.1 Jahid Ali Rojan Ali Qureshi @ Java Murgi be released on his executing P R. Bond of Rs.10,000/- (Rs. Ten Thousand) subject to comply the order of bail dated 13/03/2026 i.e. to make arrangement of solvent surety of Rs.15,000/- or if solvent surety is not available, to deposit cash bail of like amount, within four weeks.
- (iii) The copy of this order be forwarded to the applicant/accused through the Superintendent of Jail, via e-mail.
