

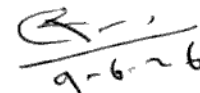

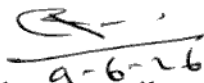

JUDGMENT

(Delivered on 9th day of June, 2026.)

The representative of accused namely Mr. Sonu appeared before Court. He submitted application for pleading guilty along with the authority letter submitted by his employer/original accused. He has also filed on record the self attested copy of his aadhar card. He submitted before the court that he wants to plead guilty voluntarily on behalf of the accused-firm. Therefore, the representative of accused is liable to be

convicted. Heard the representative of accused on the point of the sentence. He has prayed for leniency. Considering submissions of the representative of the accused, in my view, lenient view will have to be taken. Hence, I pass the order :-

ORDER

- 1) The representative of accused namely Sonu is convicted for the breach of (1): Rule 25(2)(viii) and (2): Rule 82(1) punishable under Section 24 of the Contract Labour (Regulation and Abolition) Act, 1970, vide section 275 of the Bhartiya Nagrik Suraksha Sanhita, 2023 and he is sentenced to pay a fine of Rs.800/- (Rs. Eight Hundred) for each breach. In default of payment of fine, he shall undergo imprisonment for 15 (fifteen) days.

(Total fine : 02 X Rs.800/- = Rs.1,600/- (One Thousand and Six Hundred)
