ORDER PASSED BELOW EXH.1

1. Read the application. Perused say of Ld. A.PP & I.O. Read the documents filed with the application. Heard both sides.
2. This is an application filed by applicant for defreezing the bank account and return of the amount of Rs.60,000/- (Rs. Sixty Thousand).
3. Case of the applicant is that he is cheated of Rs.60,000/- (Rs. Sixty Thousand). Dadar police station is investigating in case vide Cyber application registered by the applicant and freezed the amount of Rs.60,000/- (Rs. Sixty Thousand). The said amount is still lying with the bank account of the accused. On the complaint of the applicant the investigating officer has freezed the bank account of accused, hence, the present application is filed for defreezing the bank account of accused and to return that amount.

4. The amount is still lying with Bank. No one has claimed their ownership over that amount. The bank statement and other documents shows that the applicant is entitled for that amount.
5. Therefore, prima-facie applicant has established his right over the amount to the tune of Rs.60,000/- (Rs. Sixty Thousand) lying in the Bank of Baroda A/c No.52210100002208.
6. Therefore, I am of humble opinion that there is no hurdle to grant prayer of the applicant. In this view of matter, I pass the following order:

ORDER

- 1 The application is allowed.
2. The Sr. PI of Dadar Police Station is directed to defreez the bank account of Rs.60,000/- (Rs. Sixty Thousand) lying in the Bank of Baroda, A/c No. 52210100002208 which was freezed in crime registered with Dadar Police Station on execution of indemnity bond of Rs.60,000/- (Rs. Sixty Thousand) by the applicant.
3. Bank of Baroda is directed to handover an amount of Rs.60,000/- (Rs. Sixty Thousand) to the applicant from Bank of Baroda, bank A/c No. 52210100002208 with your branch after receiving the request letter from Dadar Police Station for defreezing the account and transfer that amount in the bank account of applicant with Axix Bank, Dadar (W) Branch, Mumbai, A/c. No.5107454111, IFSC Code UTIB0001902.
4. Bank of Baroda is at liberty to put concerned account on hold for remaining amounts lying in the concerned account after

handing over the amount as ordered above.

5. Investigating Officer is directed to submit indemnity bond either along-with chargesheet or final report.
