2. A report is submitted in pursuance of the above said matter at Dadar Police Station N.C.R. Portal Application No. 21905260063191 in the name of the Applicant. The Applicant is victim of online financial fraud, the whatsapp link was received by unknown person. Thus, crime was registered. On cybercrime toll free number 1930. The Online complaint No. 21905260063191 was registered U/Sec. 503 of Bharatiya Nagarik Suraksha Sanhita. Accordingly total amount of Rs. 43,100/- (Rupees Forty Three Thousand One Hundred Only) out of which amount of Rs. 29,000/- (Rupees Twenty Nine Thousand Only) was put on hold by the Respondent. (The copy of the Online complaint is annexed and marked as **EXHIBIT "B"** and the copy of the Bank passbook is annexed and marked as **EXHIBIT "C"**).
 3. That, at the instance of the police, Respondents have freezed the account of the Accused persons, where the amount of Rs. 29,000/- (Rupees Twenty Nine Thousand Only) of the Applicant is lying.
 4. That, the said cash was used by the Accused. The said cash was recovered by the concern Dadar Police Station, since then it is in their custody.
 5. That, the Applicant is the rightful person to claim the custody of the said cash, as it stands in his name.
 6. That, the said cash is required by Applicant for daily work purpose, therefore, the application for return of property is filed by me.
 7. That, the Applicant has not made any application for return of property before any Court of Law (except) the present application.
 8. That, this Hon'ble Court is having the jurisdiction of Dadar Police Station, Mumbai, hence, this Hon'ble Court has jurisdiction to try and entertain this application.

9. I hereby undertake to make present the said cash before the investigating officer, or to this Hon'ble Court as and when required.
10. **It is, therefore, prayed by the Applicant that:**
- (a) That the present Miscellaneous Application may kindly be allowed for defreezing of bank accounts of the Accused lying in bank accounts and thereby release partly seized amount of Rs. 29,000/- lying in Account of the Accused persons, in connection with ONLINE COMPLAINT NO. 21905260063191 filed by the Applicant with Dadar Police Station, Mumbai, and may kindly be returned to the Applicant after due verification as per law;
 - (b) That the police attached to Dadar Police Station, Mumbai in their ONLINE COMPLAINT NO. 21905260063191 with Cyber Portal be directed to verify the genuineness of the documents provided by the Applicant and verify that the ownership of the original bank account of the Applicant herein.
 - (c) For such and other ad-interim, interim and final reliefs as this Hon'ble court may deem fit and proper.
 - d) Any other and further order/s be passed in favour of the Applicant as this Hon'ble Court deems fit and proper in the facts and circumstances of the case.
