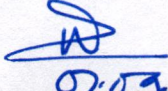

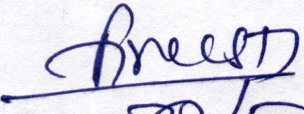
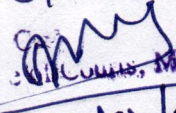

for leniency. Considering submission of the accused, I pass the order.

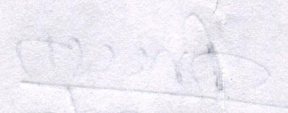
ORDER
