**ORDER PASSED BELOW APPLICATION FILED BY ACCUSED/APPLICANT FOR
GRANTING PERMISSION TO GO ABROAD**

1. Read the application. Perused, say filed by Ld. APP. Read the documents filed with the application. Heard both the sides. Applicant has made this application for permission to go abroad. He is the accused in C.R. No. 54/2019 C. C. No. 76/PW/2021 registered with Shivaji Park Police Station for the offences punishable under sections 452, 420, 465, 467, 471 r/w 34 of the Indian Penal Code. He is on bail.

2. It is submitted on behalf of the applicant that he is intend to go to HKT, Phuket, Thailand with his friend during the period from 11.09.2026 to 14.09.2026. Since the case is pending, he cannot travel abroad without prior permission of this Court. Hence, the present application.

3. Hence, he is constrained to file present application. The Ld. A.P.P has submitted his say and opposed the application.

4. Offences punishable under sections 452, 420, 465, 467, 471 r/w 34 of the Indian Penal Code are alleged against accused. Ld. Advocate of accused is ready to conduct the case in absence of accused.

To that regard undertaking is also filed on record. Therefore, I am of view that no prejudice will be caused to the prosecution if the prayer of the applicant is granted. Applicant is seeking permission to travel abroad. Therefore, permission can be granted for limited period only. Application deserves to be allowed. Hence, in result following order is passed:

ORDER

- 1 The application is allowed.
- 2 The applicant/accused is permitted to go abroad i.e. HKT, Phuket, Thailand during the period from 11.09.2026 to 14.09.2026 subject to condition that he shall execute P.R. Bond of Rs.20,000/- (Twenty Thousand) and deposit cash of Rs. 20,000/- in the court as a security.
- 3 The applicant/accused shall furnish all the details of his stay in abroad and his contact number with the Investigation Officer before start of the journey.
- 4 The applicant/accused shall submit verified copy of his passport and other relevant documents with the Investigation Officer.
- 5 On his returning, the applicant/accused shall inform the Investigation Officer immediately.
