

Deposition of Witness No. 01 for Prosecution.

Exam.-in-chief by APP Shri. K. S. Jamdhade for the State:-

1. On 25.07.2011 from 20:00 hrs. till 08:00 hrs. of 26.07.2011 I was working as Assistant Immigration Officer holding charge of Duty Officer, at C.S.M.I. Airport, Terminal-II, Mumbai. While I was on the duty on night intervening 25th and 26th July, at about 3:00 a.m. Air India staff brought one Indian National as a deportee with deportee notes and handed him over to Wing Incharge, Mr. Goon. Mr. Goon instructed me to take the statement of the passenger. It was revealed during inquiry that he passenger departed in the year 2005, to work as an electrician to Saudi Arabia, he had disputes with his employer in respect of salary, without taking the passenger from the employer he went to Madina. There he was caught by the police, probably in the year 2007, he was sentenced to jail. The Indian Embassy then issued Emergency Certificate and the Saudi Immigration took his finger prints and eye scans The passenger was black listed by Saudi Immigration and deported to India. On his arrival at Mumbai

Airport, the passport of passenger was impounded and impounding slip was issued to him. Thereafter, the passenger worked for four years in India and he applied for new passport, by concealing the fact of being black-listed in the year 2007. The application for new passport was made without submitting impounding slip in the passport office and partially changing his name. Thereafter he obtained Saudi Visa with new bio details. He departed by Air India flight 921 for Saudi on 25.07.2011. When he reached at Riyadh, the Saudi Immigration had taken his finger prints and eye scans and found that he was black-listed in the year 2007. Thus the Saudi Immigration immediately deported him by flight No. Air India 920 on 26.07.2011. After this revelation during inquiry I lodged complaint at Sahar Police Station. While lodging report I submitted the Saudi visa, deportee note, passport of the passenger and statement of the passenger, information sheet given by Air India. The F.I.R. & printed F.I.R. are now shown to me. They bear my signature. Their contents are true and correct. They are mark as **Exh-05** and **Exh-06**. The accused is present before Court today.

Examination-in-chief is complete

Cross-examination by Learned Counsel Mr. C. S. Jadhav for accused:-

(At this stage learned Advocate for accused moved an application at Exh-7 seeking adjournment in the matter. The application at Exh-7 is rejected for the reasons mentioned therein. After reading the order passed below Exh-7, learned advocate for accused Mr. C. S. Jadhav submitted that he will not be conducting the cross-examination.
