ORDER BELOW BAIL APPLICATION

This application for granting bail is filed on behalf of accused Saeed Ahmed Mastan Shaikh @ Ali who came to be arrested for the offence under Section 305(a), 331(1), 331(2) of the Bharatiya Nyaya Sanhita, 2023.

2. The IO and the learned APP for State have filed say and submitted that, the offence is serious in nature. Investigation of the crime is in progress. Stolen property is yet to be recovered. The accused is habitual offender and if he released on bail, he will again commit similar offences and will abscond.

3. Heard both the sides and perused remand papers.

4. On perusal of remand report, it appears that, present accused alongwith co-accused has committed theft of cash of Rs.38,500/-. The articles used for committing theft are recovered. The alleged offence is triable by JMFC Court. The present accused is resident of Mumbai and he is ready to obey the terms and conditions imposed by this Court and it will further take time for conclusion of trial after examination of witnesses. Further the presence of accused during the trial can be secured by imposing terms and conditions imposed by this Court. Therefore, no purpose will be served by keeping him behind the bar. Hence, I proceed to pass following order :

ORDER

i) The application filed by the applicant/accused Saeed Ahmed Mastan Shaikh @ Ali is allowed.

ii Accused be released on executing P. R. bond and S.B. of Rs.20,000/- (Rupees Twenty Thousand only).

iii The accused shall not hamper or tamper the prosecution evidence in any manner and shall not commit similar offence in future.

iv. The accused to furnish his identity proof alongwith correct address proof and mobile number.

v. Accused is directed to attend D.N.Nagar Police Station on each Monday 11.00 am to 2.00 pm till filing of charge-sheet and PSO of D.N.Nagar Police Station to maintain the record of attendance.
