ORDER ON BAIL APPLICATION NO.496/BA/2026

This is an application filed by the accused Mijaan Tayyaz Alam Khan for releasing him on the bail. He is innocent and he is falsely implicated. Stolen property has been recovered. Investigation is completed. He is ready to abide the conditions of bail, if he released. He is ready to cooperate with the investigation and he will not tamper with the prosecution. Therefore, prayed that accused be released on bail.

2) Learned A.PP and I.O. filed their say and strongly opposed to this application.

3) Perused the record. The offence is non bailable, but it is triable by this Court. Muddamal property has been recovered from him. The police sought MCR which shows that an investigation in this crime is almost completed and custody of accused is no more required. Considering the nature of offence, punishment prescribed of the same and facts of the case, no purpose will be served to keep accused behind bar and he is entitled for conditional bail. Hence, I pass following order. :-

<u>ORDER</u>	
1.	The application is allowed.
2.	The accused is released on bail on executing P.R. Bond of Rs.15,000/- (Rs. Fifteen Thousand only) and solvent surety of like amount or cash bail in the like amount is allowed.
3.	He shall submit his and his relatives address proof and personal Identity proof and mobile number.
4.	He shall co-operate the Investigating Officer during investigation.

5.	He shall not tamper with the prosecution evidence.
6.	He shall not involve himself in like offences.
