5. Particulars of offence :-

Firstly, that on 02.01.2020 at about 18.20 hrs., at near Bodla Village, Bodla to Vavi Road, Dhadgaon, you drove Mahindra Max bearing registration no. MH-20/Y-5127 on public way in a manner so rash and negligent as to endanger human life or to be likely to cause hurt or injury to informant Nabhya Gunjarya Valvi and other persons namely Sunita Sakrya Thakre, Pratibha Sakrya Thakre and Ruta Mona Patle and thereby committed an offence punishable under section 279 of the Indian Penal Code, 1860 and within my cognizance.

Secondly, that on the aforesaid date, time and place, you accused caused hurt to above said informant and others by driving your aforesaid vehicle rashly and negligently so as to endanger to human life or personal safety of others and yourself thereby committed an offence punishable under section 337 of Indian Penal Code and within my cognizance.

Thirdly, that on the same date, time and place, you caused grievous hurt to above said informant and others by driving your aforesaid Vehicle rashly and negligently so as to endanger to human life or personal safety of others and thereby committed an offence punishable under section 338 of Indian Penal Code and within my cognizance.

Fourthly, you on the aforesaid date, time and place you drove above said vehicle and committed mischief by causing wrongful loss or damage more than Rs.50/- to the above said vehicle and that you have thereby committed an offence punishable under section 427 of the Indian Penal code, 1860 and within my cognizance.

Lastly, on the aforesaid date, time and place, you drove your above said vehicle without possessing valid driving license and thereby committed an offence under Section 3(1)/ 181 of the Motor Vehicles Act and within my cognizance.
