Firstly, that you on 18.06.2018 at about 19.00 Hrs., at Mandavi Bdr., Saplapada, Tal.Dhadgaon, you all accused were a member of an unlawful assembly and in prosecution of the common object of said assembly was to cause hurt to the informant namely Aahlibai Bhika Patle and her daughter Sarita Bhika Patle and thereby committed an offence punishable under Section 143 r/w. 149 of the Indian Penal Code and within my cognizance.

Secondly, that on the same date, time and place, you all accused were members of an unlawful assembly and in prosecution of the common object of the said assembly, committed an offence of rioting

and you have thereby committed an offence punishable under section 147 r/w. 149 of Indian Penal Code.

Thirdly, that on same date, time and place, you all accused were members of unlawful assembly and in furtherance of your common object you all accused by means of wooden sticks voluntarily caused hurt to above named informant which is an instrument which used as a weapon of offence likely to cause death and thereby committed an offence punishable under Section 324 r/w. 149 of the Indian Penal Code and within my cognizance.

Fourthly, that on same date, time and place, you all accused were members of an unlawful assembly and in furtherance of your common object of the said assembly, intentionally insulted above namely informant by words and thereby gave provocation to informant to intending or knowing it to be likely that such provocation will cause above informant to break public peace or to commit any other offence and thereby committed an offence punishable under section 504 r/w 149 of Indian Penal Code and within my cognizance.

Lastly, that on same date, time and place, you all accused were members of an unlawful assembly and in furtherance of your common object of the said assembly, committed criminal intimidation by threatening the above named informant and thereby committed an offence punishable under section 506 r/w 149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge :
