CHARGE

I, Pankaj R. Phulari, Judicial Magistrate, First Class, Dhadgaon do hereby charge you,

Age :- 23 Yrs, Occ.:- Labor,
2. Lala @ Rohit Suresh Vasave,
Age :- 23 Yrs, Occ.:- Labor,
3. Somnath Bhamtya Valvi,
Age :- 28 Yrs, Occ.:- Labor,
4. Raju Bhatesing Gavit,
Age :- 29 Yrs, Occ.:- Labor,
5. Avinash Raman More,
Age :- ---, Occ.:- Labor,
6. Gaurav Bhagvan More,
Age :- 27 Yrs, Occ.:- Labor,
7. Nilesh Raman More,
Age :- 20 Yrs, Occ.:- Labor,
All R/o Khandbara, Tal. Navapur,

...as follows.

Firstly, that on 16.06.2021 at about 09.30 p.m., at Hotel Nisarg, Bardipada, Khandbara, Tal. Navapur, you all accused were members of an unlawful assembly, the common object of which was to cause hurt, threaten, insult of the informant Dikshit Ramsing Valvi and Ramsing Valvi and you all thereby committed an offence punishable under section 143 R/w 149 of the Indian Penal Code and within my cognizance.

2. Secondly, on the aforesaid date, time and place, you all accused were member of an unlawful assembly and in prosecution of the

above mentioned common object of said assembly, caused hurt to the informant and others used force and violence to them and thereby committed an offence of rioting punishable under section 147 R/w 149 of the Indian Penal Code and within my cognizance.

3. Thirdly, on the aforesaid date, time and place, you all accused were members of an unlawful assembly and in prosecution of the above mentioned common object of said assembly voluntarily caused hurt to informant and others by means fist and blows and thereby committed an offence punishable under section 323 R/w 149 of the Indian Penal Code and within my cognizance.

5. Fourthly, on the aforesaid date, time and place you all accused were members of an unlawful assembly, and in prosecution of the above mentioned common object of the said assembly intentionally insulted the informant and others by abusing them in filthy language and thereby gave provocation to her intending it to be likely that such provocation will cause him to break public peace and thereby committed an offence punishable under section 504 R/w 149 of the Indian Penal Code and within my cognizance.

6. Lastly, on the aforesaid date, time and place, you all accused were members of an unlawful assembly, and in prosecution of the above mentioned common object of the said assembly committed criminal intimidation by threatening the informant and others to kill them with intent to cause alarm to her and thereby committed an offence punishable under section 506 R/w 149 of the Indian Penal Code and within my cognizance.

And I hereby direct that, you be tried by this court on the said charge.
