Exam-in-chief:By A.P.P. Shri. R. R. Magare for the prosecution-

I have completed MBBS. I am practicing as doctor since 2010. I have examined number of patient. On 02.09.2022 I was working as a Medical Officer at Sub District hospital Akkalkuwa, Tal. Akkalkuwa, Nandurbar. On that day one Subhash Bharatsing Vasave, aged about 35 years was referred by police station, Akkalkuwa. I physically examined him at about 07.15 a.m. and found following injuries on his person.

1. Contusion, reddish in colour on left Ear upper part of size 4 x 2 cm.
2. Laceration on right Cheek lateral to right angle of mouth of size 1x1x0.5 cm.
3. Fracture left inter dipp
4. Fracture proximal base of left middal fingure
5. Fracture of right side ribs

2. The age of injuries was within 24 hours of examination and caused by hard and blunt object. Nature of injuries Nos. 01 and 02 are simple and injuries Nos. 03 to 05 are grevius. Accordingly, I issued injury certificate. Now injury certificate shown to me. It is in my own handwriting and bears

my signature. It's contents are true and correct. It is marked at **Ex.79**. Now, article-A MP No.04/2023 shown to me. Article-A is hard and blunt object. Above mentioned injuries are possible by article-A.

3. It is true to say that, original MLC register is not with me. It is true to say that, I cannot state the actual number of patient examined by me on 02.09.2022. It is true to say that, I have not given X- ray report to investigation officer. It is true to say that, above mentioned injuries are possible if, fallen on wooden base material. It is not true to say that, I have issued false injury certificate on the say of police. It is not true to say that, I am deposing false.
