**ORDER BELOW EXH-01 IN CIVIL M.A. NO.262/2025**

**(Passed on 10.04.2026)**

This is an application for grant of heirship certificate u/s. 2 & 3 of Bombay Regulation Act VIII of 1827.

2) The applicants have contended that, they are the heirs of deceased **Rema Bolya Vasave** who died on **10.08.2006** at Namardanagar, Tal. Taloda, Dist.Nandurbar. The applicants have contended that, the applicant No.1 is the wife, the applicant Nos. 2 to 5 are the sons, the applicant Nos. 6 to 9 are the daughters of deceased **Rema Bolya Vasave**. The applicants requires the heirship certificate for the Government and semi Government purpose. Applicants submitted that, they are the heirs of the deceased **Rema Bolya Vasave**. There are no heirs other than them. So, they prayed for allowing an application and issuing heirship certificate in their name.

3) After filing of this application, public notice was issued in the daily Newspaper "**Dainik Batmidar**" at Exh.12 dated 10.01.2026 and objections were called, if any. Till today nobody has filed any objection to issue the heirship certificate of the deceased in the name of the applicants.

4) In support of this application, applicant No.4 has adduced the evidence by way of affidavit vide Exh.11 before the Court. In his evidence affidavit, he has reiterated the same facts as per contentions of an application. According to him, they are the heirs of the deceased **Rema Bolya Vasave**. In support of this application, they filed following documents on record :

5) The applicants filed evidence close pursis at Exh.25. The evidence adduced by the applicants remained unchallenged as nobody appeared and cross-examined to the applicants. The claim of the applicants for grant of heirship certificate has gone unchallenged. Moreover, the heirship certificate is merely a formal recognition that the applicants are the legal heirs of the deceased. Therefore, I am inclined to issue heirship certificate by showing applicants as heirs of the deceased **Rema Bolya Vasave**. Hence, I proceed to pass the following order.

### ORDER

1.	Application is allowed.
2.	Issue heir-ship certificate in favour of the applicant Nos. 1 to 9 showing them as legal heirs of deceased <b>Rema Bolya Vasave</b> . On deposit of court fees as per rule.
