ORDER BELOW EXH. 05

(Dictated and pronounced in open Court)

Applicant-wife of informant is alleged to have transferred property owned by husband in her own name by way of fraudulent Hibanama dated 03-07-2017 and thereby cheated the informant-husband.

2. Mr. S.M.Chaoosh, learned advocate for the applicant submits that already the informant has filed divorce petition against applicant before Family Court, Nanded bearing No. A 08/2023. So also the husband has also filed Civil Suit in respect to said *Hibanama* and same is pending before the Court of Learned Civil Judge Sr. Dn. Nanded bearing Spl. Civil Suit No. 07/2023. He submits that lodging of present FIR is out of animosity against the applicant. He submits that allegations in FIR are baseless. It does not attract any penal provision. He seeks ad-interim protection from arrest.

3. Considering submissions made by the learned advocate for the applicant and allegations contained in the FIR, I find applicant deserves protection from arrest till filing of reply. Hence, the order.

ORDER

A]	Ad-interim protection is granted to the applicant.
B]	In the event of the arrest of applicant Dr. Shahina Jabeen W/o Faisal Bin Ali , in connection with C.R.No. 56 of 2026 , registered with Nanded Rural Police Station Nanded, Dist-Nanded for offence punishable under sections 420, 464, 465, 467, 471 of the Indian Penal Code, she be released on bail on furnishing PR bond in the sum of Rs.15,000/- (Rs.Fifteen Thousand only) with S.B. in the like amount till filing of reply.
C]	Applicant to co-operate in the investigation and to attend the police station if required by the Investigating Officer.
D]	Applicant to add informant as a party respondent.
E]	Issue notice to the respondents, private notice to the informant permitted.
F]	Matter adjourned to 18-05-2026.
