J U D G M E N T

Today accused is present in the court. He filed application Ex. for pleading guilty. The particulars(Ex.) of offence U/Sec.285 of IPC is read over and explained to him. He has voluntarily pleaded guilty in spite of informing him consequences of pleading guilty. In view of this submission, his plea is accepted and accused is held guilty for the offence U/Sec.285 of IPC.

The accused is heard on the point of sentence. He has submitted that he will not commit the same offence again and leniency may be shown while awarding the sentence. Considering the submissions of accused, the sentence in the form of fine will be justified. Hence, I proceed to pass following order :

O R D E R

- 1) The accused Mohd. Haroon Mohd. Jumar Shaikh is convicted as per section 255(ii) of Cr.P.C. for the offence punishable U/Sec.285 of IPC and he is sentenced to suffer imprisonment till rising of the court and to pay fine of Rs.500/- (Rupees Five Hundred only) i.d. to suffer simple imprisonment for two days.
- 2) The copy of judgment be given to the accused free of cost.
- 3) Dictated and declared in open court.
- 4) Muddemal property i.e. iron stove be returned to the accused.
