The applicant is seeking regular bail invoking

section 483 of Bharatiya Nagarik Suraksha Sanhita 2023 in connection with above mentioned crime registered with Himayatnagar Police Station for the offences enumerated above.

2] Heard both the sides.

3] Prosecution case is that on 25-05-2009, in the night, the deceased Shaikh Babu Sk. Karim was put to death by the applicant and his companions in prosecution of their common object.

4] The accused Nandu Ramsingh Shingare and Kaliya Shingare were tried vide Sessions Case No.19/2011 and held guilty for the offence punishable under section 302 read with section 149 of IPC and sentenced to suffer rigorous imprisonment for life. During the trial, accused Nandu was on bail.

5] The present applicant was absconding and charge sheet was filed against him invoking section 299 of Cr. P. C.. A period of more than one year is lapsed, there is no progress in the trial. Vide order dated 08-05-2026, co-accused Hari Gulab Chavan was admitted on bail. Hence, rule of parity is extended and application is allowed on following terms and conditions.

- 1) The applicant be released on bail furnishing PR bond of Rs.50,000/- (Rs. Fifty Thousand only) with one or two solvent surety of like amount.
- 2) The applicant shall not directly or indirectly make any

inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the investigation officer or tamper with the evidence.

- 3) The applicant shall not contact the informant and his family members till the conclusion of trial.
- 4) The applicant shall submit his residential address and contact numbers to this Court within seven days from the date of this order.
- 5) The applicant shall attend the trial regularly and co-operate for expeditious conclusion of trial.
- 6) The violation of aforesaid conditions would entail the cancellation of bail.
