ACP S.N.Jhala In-charge of Police Escort, Ahemdabad states that the case against accused Mohd. Mansoor Asghar Peerboy is pending in Ahemdabad Court. Considering the said fact it is not possible

to detain the accused Mohd. Mansoor Asghar Peerboy in Delhi and therefore, he be produced as and when the Court directs as he has already been produced from video conferencing as well as physical production of same.
