**CHARGE**

I, V. B. Salunke, Judicial Magistrate, F.C., Dharmabad is hereby charge you.

- 1] Mirza Javidbaig Sadakbaig,  
Age – 51 Years, Occu –Agri.,  
R/o Sirajkhod, Tq. Dharmabad, Dist-Nanded.
- 2] Mirza Rihanbaig Javidbaig,  
Age – 23 Years, Occu –Agri.,  
R/o Sirajkhod, Tq. Dharmabad, Dist-Nanded.
- 3] Yasminbee Javidbaig,  
Age – 43 Years, Occu –Agri.& household,  
R/o Sirajkhod, Tq. Dharmabad, Dist-Nanded.
- 4] Mirza Furkhanbaig Javidbaig,  
Age – 21 Years, Occu –Agri.,  
R/o Sirajkhod, Tq. Dharmabad, Dist-Nanded.

**As follows :-**

- 1) That, you in furtherance of your common intention on 12-05-2020 at 07.00 p.m. at Sirajkhod, Tq. Dharmabad, Dist-Nanded voluntarily caused hurt to informant Sayyed Dadu Sayyed Khaja Miya by means of iron blower(pipe) and thereby committed an offence punishable u/s 324 r.w. 34 of Indian Penal Code, and within my cognizance.
- 2) That, you in furtherance of your common intention on above mentioned date, time & place voluntarily caused hurt to

informant Sayyed Dadu Sayyed Khaja Miya & thereby committed an offence punishable u/s. 323 r.w.34 of Indian Penal Code and within my cognizance.

3) That, you in furtherance of your common intention on above mentioned date, time & place intentionally insulted informant Sayyed Dadu Sayyed Khaja Miya & thereby gave provocation to him intending or knowing it to be likely that such provocation will cause informant to break public peace and thereby committed an offence punishable u/s 504 r.w.34 of the Indian Penal Code and within my cognizance.

4) That, you in furtherance of your common intention on above mentioned date, time & place committed criminal intimidation by threatening informant Sayyed Dadu Sayyed Khaja Miya to cause death with intent to cause alarm to him and cause him to do any act which he is not legally bound to do, or to omit to do any act which he is legally entitled to do, as the means of avoiding the execution of such threat, and that you have thereby committed an offence punishable u/s sec. 506 r. w. 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by me for the said charge.
