

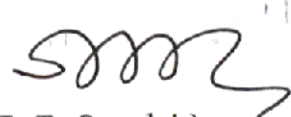


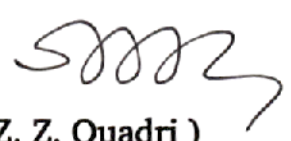

ORDER

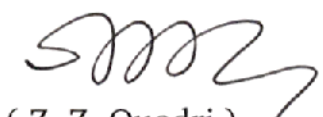
