**Order Below Exh.01**

The applicants have filed this application under the provisions of Bombay Regulation Act VIII, 1827 for issuance of heirship certificate. The applicants in support of their claim have filed documents along with affidavit of evidence of applicant no.01 Savitabai Bhavsing Rathod at Exh.11.

2. It is contended by the applicants that, husband of applicant no. 1 and father of applicant no. 2 namely Bhavsing Dhansing Rathod died on 20/08/2017 at Kothari (C), Tal. Kinwat Dist. Nanded, they are only legal heirs of deceased Bhavsing Dhansing Rathod. The father and mother of deceased are also died. They require the heirship certificate for official and non-official work. Hence, they have approached this Court for grant of heirship certificate.

3. In support of their claim, applicants have filed documents i.e. Death Certificate of deceased Bhavsing Dhansing Rathod issued by Gramsevak (Death & Birth), Grampanchayat Kothari (C), Tal. Kinwat, Dist. Nanded at Exh.12, heirs certificate of deceased issued by Sarpanch, Grampanchayat Kothari (C), Tal. Kinwat, Dist.Nanded at Exh.13 and copies of their Aadhar cards of applicants at Exh.14 & 15.

4. Death certificate at Exh.12 and heirs certificate at Exh.13, reveals that Bhavsing Dhansing Rathod died on 20/08/2017. After completion of all formalities, publication was made in the daily newspapers Daily Goanwala dated 29/01/2026 at Exh.16 and objections were called, but after publication, nobody has raised any objection regarding the claim of the applicants till date. The contentions of applicants have been supported by affidavit of evidence of applicant no.01, which has remained unchallenged. Thus, since there is no any objection received within stipulated

period regarding the claim of applicants, in my opinion, applicants are the only legal heirs of deceased Bhavsing Dhansing Rathod.

5. In view of foregoing discussion, it is crystal clear that, applicants have prima-facie proved their claim for issuing heirship certificate, and there is no bar to issue the same in their favour. In the result, I proceed to pass following order.

**ORDER**

- 1 Application is allowed.
- 2 Issue heirship certificate in the name of applicants on their depositing requisite Court fees.
