(Delivered on 22/04/2025)

Accused No. 02 & 03 have been prosecuted for the offence punishable under section 84 of Maharashtra Prohibition Act, 1949. Accused No.02 & 03 are present before the court and they pleaded guilty. I am satisfied that they are voluntarily pleading guilty. Hence, I accept their plea of guilty.

02. Heard accused No.02 & 03 and their learned counsel as well as learned APP on the point of sentence. Considering the nature of the offence, age of accused and submission of accused that they are poor and it is their first offence, it will not just and proper to pass stringent punishment. Considering all these circumstances, I pass following order.

Accused Nos. 02 & 03 are hereby convicted for offence punishable U/Sec. 84 of the Maharashtra Prohibition Act, 1949 vide section 275 of the BNSS and sentenced to pay fine of Rs.1000/- (Rs. One Thousand Only) each, in default to suffer simple imprisonment for three days.
