**ORDER BELOW EXH.1**

The applicants have filed this application for grant of Heirship Certificate.

2. It is contended in the application that, applicant No.1 is the wife, applicant No.2 is the son and applicant no. 3 is the married daughter of deceased Prabhuappa Sarangappa Swami who died on 31/10/2025 at Kamtha Bk., Tq. Ardhapur Dist. Nanded. Hence, the applicants prayed to issue Heirship Certificate in their name.

3. In support of their application, the applicant No.2 has filed his affidavit by way of Examination in Chief vide Exh.9 and relied upon the documents namely death Certificate of deceased Prabhuappa Sarangappa Swami at Exh.10 issued by Gram Panchyat, Kamtha Bk. Tq. Ardhapur Dist. Nanded, verified copy of election card of deceased Prabhuappa Sarangappa Swami is at Exh. 11 and verified copies of Adhar card of applicants at Exh.12 to 14. Citation notice was issued and applicants have placed on record Public Notice published in daily newspaper "Dainik Gavwala and Dainik Dalitwani" dated 11/02/2026 and 12/02/2026 vide Exh 15 and 16 respectively.

4. The applicant No.2 has averred in his affidavit that, applicants are the only legal heirs left behind by the deceased Prabhuappa Sarangappa Swami and prayed to issue heirship certificate in the name of applicants. They required the said heirship certificate for official and non official purpose. On perusal of the evidence on record, it appears that applicants are only heirs of deceased Prabhuappa Sarangappa Swami. Moreover, in spite of citation notice and Public Notice published in daily newspaper "Dainik Gavwala and Dainik Dalitwani" dated 11/02/2026 and 12/02/2026 vide Exh 15 and 16 respectively,

nobody appeared and objected the claim of applicants within stipulated period.

5. Considering the contentions in the application, affidavit of applicant No.2, documents filed on record and that the testimony of applicant no.2 remained unchallenged as nobody has objected the claim of applicants, I am of the view that, the applicants are entitled to Heirship Certificate. Hence following order is passed.

**ORDER**

- 1) Application is allowed.
- 2) Issue Heirship Certificate in the name of applicants as per rules for their formal recognition as heirs of deceased Prabhuappa Sarangappa Swami and not for the management of the properties of deceased person or for any other ancillary purpose connected with properties of the deceased.
