**ORDER BELOW EXH.1**  
(Passed on 23.03.2026)

This is an application filed by the applicant Pramod S/o. Prakashrao Kalyankar R/o. Pimpalgaon (M), Tq. Ardhapur Dist. Nanded for interim custody of vehicle i.e. Tata Truck Tipper bearing registration No. MH-26-AD-2228 on supurtnama.

2. It is submitted by the applicant that the said vehicle was seized by Ardhapur Police Station, in crime No. 124/2026 registered for the offence punishable under section 303 (2) of BNS R/w. 48(8)(7) of Maharashtra Land Revenue Code. The applicant is owner thereof. Therefore, no useful purpose will be served in keeping the said vehicle. Accordingly, it is prayed that the vehicle be handed over to the applicant on supurtnama.

3. The learned APP and I.O. have filed their say and strongly opposed to hand over the said vehicle to the applicant. Hence, they prayed to reject the said application.

4. The applicant has filed on record the, verified copy of R.C. Book, xerox copy of insurance policy, verified Copy of aadhar card and certified copy of F.I.R., The document in the nature of verified copy of Registration of Certificate evidently shows that the applicant is the owner thereof. Thus, in view of above, the applicant is entitled to the interim custody of the vehicle. Hence, I pass the following order:-

**ORDER**

1. The application is allowed.
2. Ardhapur Police Station, is directed to hand over the custody of seized vehicle i.e. Tata Truck Tipper bearing registration No. MH-26-AD-2228 in crime No. 124/2026 to the applicant Pramod S/o. Prakashrao Kalyankar R/o. Pimpalgaon (M), Tq. Ardhapur Dist. Nanded on his

executing suprutnama bond of Rs. 12,00,000/- (Rs. Twelve Lakh only) and local surety of Rs. 1,00,000/-(Rs.One lakh Only) after furnishing surety before the court on the following conditions :-

- a) I.O. to take appropriate photographs of the above said vehicle and also prepare detail panchnama while handing over the said vehicle to the applicant and obtain his signature on the panchnama as well as on photographs and submit it alongwith charge-sheet.
- b) The applicant shall not dispose of the above said vehicle in any manner what-so-ever.
- c) The applicant shall not change or alter the nature of the said vehicle during their custody.
- d) The applicant shall produce the said vehicle as and when required by this court.
- e) The applicant shall not used the said vehicle in illegal manner.
- f) The Assistant Superintendent of this Court is directed to file the true copy of this order in crime No.124/2026 of Ardhapur Police Station.
