ORDER BELOW EXH.1
(Passed on 12.06.2026)

This is an application filed by the applicant Ritesh S/o. Ramdas Ramdinwar R/o Himaytnagar, Tq. Himayatnagar Dist. Nanded for interim custody of vehicle i.e. motorcycle bearing registration No. MH-26-CW-1379 on supurtnama.

2. It is submitted by the applicant that the said vehicle was seized by Ardhapur Police Station, in crime No. 189/2026 registered for the offence punishable under section 281,106(1),125(a)(b) and 324(4) of Bharatiya Nyaya Sanhita 2003. The applicant is owner thereof. Therefore, no useful purpose will be served in keeping the said vehicle. Accordingly, it is prayed that the vehicle be handed over to the applicant on supurtnama.

3. The learned APP and I.O. have filed their say and strongly opposed to hand over the said vehicle to the applicant. Hence, they prayed to reject the said application.

4. The applicant has filed on record the copy of F.I.R., verified copy of aadhar card, verified copy RC book, verified copy of driving license and copy of insurance of the said vehicle. The document in the nature of verified copy of RC book evidently shows that the applicant is the owner thereof. Thus, in view of above, the applicant is entitled to the interim custody of the vehicle. Hence, I pass the following order:-

ORDER

1. The application is allowed.
2. Ardhapur Police Station, is directed to hand over the custody of seized vehicle i.e. motorcycle bearing registration No. MH-26-CW-1379 in crime No. 189/2026 to the applicant Ritesh S/o. Ramdas Ramdinwar R/o Himaytnagar, Tq. Himayatnagar Dist. Nanded on his executing

suprutnama bond of Rs. 95,000/- (Rs. Ninty Five Thousand only) on the following conditions :-

- a). I.O. to take appropriate photographs of the above said vehicle and also prepare detail panchnama while handing over the said vehicle to the applicant and obtain his signature on the panchnama as well as on photographs and submit it alongwith charge-sheet.
- b) The applicant shall not dispose of the above said vehicle in any manner what-so-ever.
- c) The applicant shall not change or alter the nature of the said vehicle during their custody.
- d) The applicant shall produce the said vehicle as and when required by this court.
- e) The Assistant Superintendent of this Court is directed to file the true copy of this order in crime No.189/2026 of Ardhapur Police Station.
