Applicant- **Deepak Shyamrao Deshmukh** has filed present application to return his mobile phone (IQQ 29 X 54) bearing IMEI 1 no. 866041070891319 and IMEI 2 no. 866041070891301, seized by Police Station Barad Tq. Nanded, Dist Nanded, in its Cri. No.13/2026, for the offence under Section 12(a) of Bombay Gambling Act.

02. It is contended by the applicant that, he is the registered owner and possessor of above mentioned mobile, of which he He has filed on record Receipt of the said mobile vide **Exh-5/3**, showing his ownership and further contended that, it was seized during investigation of Crime No.13/2026. Applicant prays being in need of said mobile for his day to day work he is ready to abide any of the conditions, which will be imposed by the Court for releasing the mobile on Suprutnama/Bond. Hence, he has filed the present application to release the seized property.

03. Say of Investigation Officer and learned A.PP. called and they submitted that, if the mobile is released, the applicant would do changes or may destroy it. Hence, prayed to reject the application.

04. On the record , Copy of F.I.R. No.13/2026 of Police Station Barad, Tq. Mudkhed, Dist. Nanded along with the documents i.e. the Certificate of Registration of (IQQ 29 X 54) bearing IMEI 1 no. 866041070891319 and IMEI 2 no. 866041070891301, which is in the name of applicant, Aadhar Card vide **Exh.5/2**. Is filed and applicant

appears to be lawful owner of the seized mobile to the applicant by imposing certain conditions and proceed to pass following order:

ORDER

01. The application is allowed.
02. The mobile (IQQ 29 X 54) bearing IMEI 1 no. 866041070891319 and IMEI 2 no. 866041070891301, seized by Police Station Barad Tq. Nanded, Dist Nanded, in its Cri. No.13/2026, for the offence under Section 12(a) of Bombay Gambling Act be handed over to the applicant- **Deepak Shyamrao Deshmukh**, on executing Suprutnama/Bond for Rs.14,000/- (Rs. Fourteen Thousand Only), till the final decision of the case.
03. Applicant is directed to produce the seized mobile as and when ordered by the Court and not to change its nature, alienate, gift, transfer, hypothecate the said mobile or not to change it's identity, as well as is directed to produce photo copy of Bill Tax Invoice of the seized mobile, before Investigating Officer.
04. Investigating Officer is directed to take photographs of the seized mobile by preparing detailed Panchnama and to submit the same before the Court.
05. Suprutnama / Bond be executed by the applicant before the Police Station Barad, Tq. Mudkhed, Dist. Nanded.
06. Copy of this order, be sent to the Police Station Barad, Tq. Mudkhed, Dist. Nanded, Hamdast allowed, if required.
