1. The applicant Vinay S/o Purushottam Bhange filed an application under Section 482 of the BNSS for grant of anticipatory bail under Section 305, 324(2), 330, 189(2), 190, 191(2), 351(3), 352 and 126(2) of the Bharitya Nyaya Sanhita, 2023, in crime No.61 of 2026 is registered with police station Ranapratap Nagar. The applicant submitted that out of Civil dispute the false report has been lodged against him. The property belongs to him and it is a valuable property. Some anti-social elements are trying to grab his property. He prayed for ad-interim protection till say of police is filed.
2. I perused documents and photographs filed on record by the applicant. The photographs of CCTV shows that some persons entered the property of the applicant by concealing their faces. So in my view this is fit case for grant of ad-interim protection to the applicant till say of police is filed. So I proceed to pass following order.

ORDER

1. Ad-interim anticipatory bail in the event of arrest of applicant/accused ***Vinay S/o Purushottam Bhange***, be released on executing Personal Recognition for bond of Rs.50,000/- (Rupees Fifty Thousand only) with one surety in the like amount in Crime Register No.61 of 2026 of Ranapratap Nagar *Police Station*, for the

offence punishable U/Section 305, 324(2), 330, 189(2), 190, 191(2), 351(3), 352 and 126(2) of the Bhartiya Nyaya Sanhita, till filing of say by the Investigation officer, subject to following conditions :-

1. *The applicant shall not tamper with the evidence and the witnesses, in any manner. Further, the applicant is directed shall not directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer.*
2. *The applicant shall not commit the similar offence of which he is charged.*
3. *The applicant shall attend the police station Ranapratap Nagar on every Saturday between 10.00 am to 1.00 pm till filing of the say of the Investigating officer and co-operate with the investigation.*
4. *Applicant is further directed as to submit complete address proof and mobile number of his own and as well as two those persons who are related to him.*
5. *Notice to the prosecution and Call say of Investigating officer, returnable on 20/02/2026.*
