4] It is true to say that I did not witness the accident. It is true to say that therefore I have no personal information about the accident. It is true to say that F.I.R. was lodged by me. It is true to say that F.I.R. was lodged against unknown person and vehicle. It is true to say that in spot panchanama also no name of driver and offending vehicle is mentioned. It is not true to say that School van No. MH-31-DS-5284 was not involved in the said accident and no accident occurred by the said vehicle.

5] I have not filed on record income tax return or bank statement of my deceased father to show that he had yearly income of Rs.10,00,000/-. It is true to say that 7/12 extract also stands in our name. It is true to say that we are still cultivating. It is true to say that we are taking income from the field. It is not true to say that we were not dependent upon our father. It is true to say that in my affidavit I have mentioned my occupation as cultivator. After accident my father was admitted in hospital and he died during treatment in the hospital. I have not filed on record the medical papers. It is true to say that in postmortem report also history is mentioned as hit by unknown vehicle. It is not true to say that we have not incurred medical expenses. I have not filed the hospital bills on record. It is not true to say that I have filed false and exaggerated claim.
