Examination-in-chief of witness by Adv. Smt. Snehal Vyas for Petitioner.

1] Since 2017 I am working with South East Central Railway as account clerk. I have appeared before Tribunal as per witness summons. I have filed on record authority letter. It bears signature of Assistant Divisional Finance Manager Shri Avinash Jadhav. I know his signature. Said authority letter is at **Exh.34**.

2] As per summons I have produced on record the documents. Ramdas Sitaram Raut was working as Helper-II in Engineering department of our Railway at Kamptee. He was appointed on 26.09.2014. He was permanent employee. I have filed on record copy of office order. It is attested by Assistant Personal Officer. It is true and correct as per record. It is at **Exh.35**. Copies of Muster roll is also filed on record. They also bears signature of Assistant Personal Officer. They are at **Exh.36, 37 and 38**.

3] I have also filed on record pay slip of Ramdas for the month of January-23, February-23 and March-2023. They bear signature of Assistant Personal Officer. They are true and correct as per record. They are at **Exh.39, 40 and 41**. As per salary slip the gross salary of Ramdas for the month of March-2023 was Rs.38,523/- and February Rs.43,022/- and January Rs.42,623/-. He was not income tax payee. I have also filed on record form -16 of Ramdas. It bear signature of Assistant Personal Officer. It is true and correct as per record. It is at **Exh.42**.

Cross-examination by Adv. Ku. Akshada Brahmhapurikar holding for Adv. Smt. Kasbekar for Respondent No.1.

4] The pay slip does not bear my signature. On 14.04.2023 I was working in another section. NHA means National Holiday Allowance and NDA means Night Duty Allowance. TRANALL – is transfer allowance. NHA and NDA allowance used to pay only when work is done on National Holiday and night duty. I do not know whether employment on compassionate ground is provided to any of the family member of deceased Ramdas or what. I do not know about the pension of deceased. The age of retirement in Railway department is 60 years. I cannot tell whether Ramdas was performing duty on whole working days or what. It is not true to say that I do not know anything about the salary of Ramdas. It is not true to say that to support petitioner I am adducing evidence.

Cross-examination for Respondent No.2.

Respondent No.2 and his counsel absent when repeatedly called. Hence cross examination Nil.
