Cross-examination of PW 1 resumed on S.A. by Shri Prakash Dhoke, learned Advocate for respondent in view of order Exh. 27.

3] Date of accident is 7/5/2019. My parents told me the date of accident. Accident took place in night, however, I do not know to what O'clock the accident occurred. I was pillion rider on motorcycle of my friend namely Rishikesh Apdeo. Rishikesh was riding motorcycle. At that time, I was not knowing which vehicle

dashed from behind to the motorcycle. I don't recollect whether I felt unconscious after accident. Witness volunteers that for about one month I had totally lost my memory. It is correct to say that therefore, I do not know about the vehicle dashed to the motorcycle. Witness volunteers that, however, Rishikesh was knowing about the said vehicle. I regained conscious for 1 or 2 times when I was admitted in ICU. It is correct to say that therefore, I personally do not know about the manner of accident. It is not correct to say that since I do not know anything about the accident, my affidavit Exh. 21 has been drafted on the say of others. It is not correct to say that I do not know number of four-wheeler dashed to the motorcycle. It is not correct to say that I falsely implicated the vehicle WagonR No. MH34-K-3569 as the offending vehicle. It is correct to say that I could not notice the vehicle at the time of accident. It is not correct to say that I filed the false affidavit and deposing false. Witness volunteers that after my discharge when police came to my home to record my statement, I came to know that the vehicle involved in the accident had been caught on the same date of accident by the police. My testimony has been recorded before the Magistrate Court at Nagpur. I don't recollect whether I deposed before the said court about dash of four-wheeler to our motorcycle. I do not know that the driver namely, Chetan Barde, of the said four wheeler had been acquitted by the said court of Magistrate. I do not know that said Chetan Barde, has been acquitted as I did not depose the number of the vehicle and name of the driver of four-wheeler. It is not correct to say that my claim is false against the respondent.

It is not correct to say that I did not tell police number of four-wheeler involved in the accident. Witness volunteers that Rishikesh told the number of the vehicle and its colour to police. It is not correct to say that Rishikesh was also not knowing the number of the said four-wheeler. It is not correct to say that to extort the money I implicated respondent falsely in the matter.
