**Examination-in-Chief by Adv. Smt.Manisha Sarode holding
for Adv.Smt.Bhattad for petitioner on oath:-**

1] I have received witness summons from the Tribunal. I am running my own hospital in the name and style *"Ayushman Super Specialty Hospital"* at Ramdaspath Nagpur. Patient named Ashitosh Mate was admitted to my hospital on 18.12.2020 with the history of Road Traffic Accident, with Grade-II compound fracture tibia and fibula, right vascular injury. Patient was operated. Nailing for fracture tibia was done. Patient was discharged on 02.12.2020.

2] Final hospital bill of Rs.5,46,822/- was issued to the patient. My hospital has received entire amount of final bill in cash. Original final bill is now shown to me, contents are true and correct, it bears signature of bill Manager, it is at **Exh.31.**

3] Patient was again admitted in my hospital on 25.11.2020. Patient was discharged on 02.12.2020. 2nd Final

hospital bill of Rs.1,25,607/- was issued to the patient. My hospital has received entire amount of final bill in cash. 2nd Original final bill is now shown to me, contents are true and correct, it bears signature of clerk, it is at **Exh.32**.

4] Gauri Sut Medicos is attached to my hospital. Now original 26 Pharmacy bills are now shown to me, contents are true and correct, it bears signature of Pharmacist, they are at **Exh.33/1 to 33/26**. Pharmacy has received total amount of Rs.67,635/- in cash.

Chief Examination-completed.

Claim petition proceeded Ex-parte against Respondent No.1

Cross examination for Respondent No.2 by Adv. Shri.Modak holding for Adv. Shri. C.B.Pande on oath.

5] It is correct to say that, date of issuing bill is not mentioned. The balance amount of Rs.4,73,822/- is not received. The patient only paid Rs.73,000/-. Patient was not having any Medi Clam policy. I do not have account statement of the hospital. The business of Gauri Sut Medicos is looked after by the pharmacist and not by me.

6] I do not have personal knowledge about the payment of Pharmacy bills. I have not produced account statement of Pharmacy. It is not true to say that, I am deposing falsely without inspecting the record.
