1] I am running my own hospital in the *name & style 'Abhinav Multi Specialty, Hospital'* at 10 Number Puliya, since last six years. Patient named **Mr. Ashutosh Gajanan Mate** came to my hospital on 06.01.2022. The patient met with an (R.T.A.) accident on 24.11.2020. He was treated at Aayushman Super Specialty Hospital from 25.11.2020 to 02.12.2020.

2] Patient had sustained destruction or permanent imparting of the powers of any member or joint, or compound #tibia & fibula RT vascular injuries with multiple bodily injury. On examination I found disable. Accordingly, I assessed total disability of 15%.

3] Original Disability Certificate is now shown to me, contents are true and correct, it bears my signature and seal of my hospital. It is at **Exh.34**. Patient will have difficulty in walking for long distance, sitting on floor, climbing steps, lifting weight.
