3] I have filed Adhar card to show my age. I know Nadim Ansari. He is my brother in law. It is true to say that at the time of accident he was driving the offending vehicle. It is not true to say that he was not holding driving license. I have not filed on record his driving license. It is not true to say that my brother-in-law was not knowing driving and was not holding driving license, still he was driving the vehicle, therefore accident occurred.

4] I have not filed on record medical bills to show that I incurred

expenses of Rs.5,50,000/- on my treatment. I have also not filed on record any document to show that my treatment is still going on. It is not true to say that I did not incur expenses of Rs.5,50,000/- on medical treatment. It is not true to say that my medical treatment is not continued. It is not true to say that I did not sustain any injury in accident. It is not true to say that I have not suffered any permanent disablement. I have not filed on record any disability certificate. Presently I am doing my day to day activities. It is not true to say that I am doing all the household work. I have not engaged any maid servant for household work. It is not true to say that I have falsely contended that I incurred expenses of Rs.5,50,000/- on medical treatment. It is not true to say that I have not sustained any such injury which caused permanent disablement to me. It is not true to say that I have filed false claim. It is not true to say that I am deposing falsely. It is not true to say that I have filed false affidavit.
