S.A.**

2] At the time of accident I was proceeding from Takali to Warora on motorcycle. I was pillion rider. My labour was driving the motorcycle. I was proceeding on my motorcycle. We were proceeding from the left side of the bus. The bus came from behind. No other vehicle was coming from behind the bus. It is not true to say that, one tanker came from behind the bus. The tanker driver blew horn therefore, motorcycle driver increase the

speed of motorcycle and came in front of the bus.

3] It is not true to say that, our motorcycle gave dash to the left side indicator of the S.T.Bus. Therefore, I fell down on the divider and sustained injury. It is not true to say that, the bus driver is not at any fault. It is not true to say that, accident took place due to rash and negligent driving by the motorcycle driver.

4] I took treatment in Lata Mangeshkar Hospital. I took treatment at Warora thereafter I was shifted to Nagpur. I sustained injury to my right leg. I have not produced any document to show that my annual income out of agricultural land was Rs.15,00,000/-. The land is show in 7/12 extract is my own. Two agricultural lands are in my name and other agricultural land is in the name of my brother.

5] I was alone cultivating my agricultural land. I have given my agricultural land on rent. I am receiving income out of my agricultural land. It is not true to say that, I sustained simple injuries. It is not true to say that, I did not suffer any permanent disability. I have not produced any document to show that I spent Rs.3,00,000/- for my treatment.

6] It is not true to say that, I am deposing falsely that my annual income from agricultural land was Rs.15,00,000/-. It is not true to say that, I am deposing falsely and I have filed false claim petition. **Cross Examination Completed.**
