3] Accident occurred at about 11:00 a.m. At that time I was proceeding towards Sadar from Jaswant talkies. It is not true to say that while crossing signal, as one vehicle had come across my vehicle therefore I had suddenly applied the breaks, therefore the S.T. Bus behind me gave dash to my motorcycle. It is not true to say that at that time speed of my motorcycle was high. It is not true to say that as I had suddenly applied the breaks therefore my motorcycle skidded and I sustained injuries. It is not true to say that accident occurred due to my fault. It is not true to say that there was no fault of the driver of S.T. Bus. I had not worn helmet. My both legs were fractured. It is true to say that I had taken treatment in

Government Hospital. It is true to say that I was provided treatment free of costs. Witness volunteers that but he has incurred expenses on medicines. I have filed on record documents to that effect.

4] It is not true to say that the injuries sustained by me are now healed. I came in court by driving my two wheeler. It is not true to say that I have not suffered any disablement. I was doing work of supply of bakery material. I have not filed on record any document to show the same. I have also not filed document to show that I was getting monthly salary of Rs.12,000/-. Presently I am not doing any work. It is not true to say that I am deposing this falsely. It is not true to say that I have falsely implicated S.T. bus in the petition. I have not received any compensation from respondent. It is not true to say that I have filed false and exaggerated claim.
