

### JUDGMENT

Accused has voluntarily plead guilty for which particulars are read over and explained to him. It appears that his plea is voluntarily made. Hence, I accept the same. Heard the accused on point of sentence. He submits that it is his first offence and therefore lenient view may be taken against him. Considering these circumstances, I pass the following order:-

### ORDER

1. The accused Moh. Tufail Ahmad/Wasi Ahmad is/are convicted of the offence punishable U/s. 285 of BNS u/s vide section 275 of the Bhartiya Nyay Surksha Sanhita, 2023 and to pay fine of amount of Rs. 300/- (Rs. Three Hundred only). In default to suffer simple imprisonment for one day.
