Before framing of charge, both parties are heard and thereafter following charge is framed :-

**C H A R G E**

I, K.K. Shah, Additional Chief Judicial Magistrate, Nagpur do hereby charge you accused :-

- Accused - 1] **Kusum Raju Kesia**  
Age.: 30 yrs., Occu :  
2] **Munnibai Tikaram Kalkhor**  
Age.: 52 yrs., Occu : Household  
Both R/o. Ganga Jamuna Vasti, C/o. Munnibai Kalkhor,  
P.S. Lakadganj, Nagpur.

as follows:

That, on 17.01.2015 at 19.40 hours, at Ganga Jamuna Area, Adamshah Square, Near Balaji Temple, P.S. Lakadganj, Nagpur, you accused no.2 Munnibai found running prostitution in aforesaid building and you were found keeping said premises as brothel and allowing the premises to be used as brothel and thereby you have committed an offence punishable u/s 3 of Immoral Traffic (Prevention) Act, 1956 and within my cognizance.

Secondly, on the above said date, time and place, you both accused being major knowingly lived, wholly or in part, on the earnings of prostitution of accused no.1 Kusum and thereby you have thereby committed an offence punishable u/s 4 of Immoral Traffic (Prevention) Act, 1956 and within my cognizance.

Thirdly, on the above said date, time and place, you both accused carried on prostitution in your house at Ganga Jamuna Vasti, Lakadganj, Nagpur, which is situated within the area of 200 meters from the public place

i.e. place of worship and temple and thereby you have thereby committed an offence punishable u/s 7 of Immoral Traffic (Prevention) Act, 1956 and within my cognizance.

Fourthly, on the above said date, time and place, you accused no.1 loitered in such a manner as to cause obstruction or annoyance to persons residing nearby or passing by on the public road, near Ganga Jamuna, towards Adamshah Chowk road, Lakadganj, Nagpur, for the purpose of prostitution and thereby you have thereby committed an offence punishable u/s 8 of Immoral Traffic (Prevention) Act, 1956 and within my cognizance.

And, I hereby direct that you be tried by me on the said charge given under my hand and seal of the court.
