Jain Sales, Khadgaon Lava Road, Wadi, Nagpur the Food Safety Officer had inspected your agency and you being the owner and nominee of said agency, were found the Vanaspati Sunflower (200 ml) containing prohibited food articles for sale without licence, in disobedience of Maharashtra Government Gazette notification and such food articles tend to cause injury to any person who consume and eats the same, knowing or having reason to believe that the same is unsafe as food added to the food and thereby committed an offences punishable under sections 59 and 63 for the contraventions of Section 26(2) (i) r/w sections 27(2)(c), 3(1)(zz)(xii) of Food Safety & Standards (Food Products Standards and Food Additives) Regulation Act 2011 r/w. Regulation 2.2.6(1) and within my cognizance.
