FINAL ORDER

(Passed on 14th March, 2026)

Accused filed an pursis vide Exh.02 and pleaded guilty voluntarily. The particulars of offence punishable under Section 185 of the Motor Vehicles Act alleged to have been committed by accused was read over and explained to accused, upon which the accused admitted his guilt that he was driving his vehicle under the influence of liquor. So also, the extent of punishment prescribed for the aforesaid offence is made clear to accused, upon which he submitted that he is ready to undergo the punishment imposed by this Court. I considered his submissions and found his plea volunteer. Therefore, I hold him guilty for the offence punishable under Section 185 of the Motor Vehicles Act vide Section 275 of the Bharatiya Nagrik Suraksha Sanhita, 2023. Heard, the accused on point of sentence. He submitted that he is poor, therefore lenient view may be taken. Considering nature of offence, submissions of accused and purpose of National Lok Adalat, lenient view will have to be taken. In result, I pass the following order.

ORDER.

- 1] The accused is convicted under Section 185 of the Motor Vehicles Act vide Section 275 of the Bharatiya Nagrik Suraksha Sanhita, 2023.

- 2] Accused is sentenced to pay fine of **Rs.2000/- (Rs. Two Thousand only)**
and in default to suffer **S.I. (Simple Imprisonment) for 10 Days.**
- 3] His bail bonds stands cancelled.
- 4] Mater stands disposed off.
