**State -VS- Sachin Bombale**

**ORDER BELOW EXH.1**  
(Passed on 24/03/2026)

APP submitted that documents are received by this court from Special Investigation Team, Andheri about the report of Handwriting Expert along with certain documents which were seized by the Investigating Officer. The envelop is in stapled position along with one letter dated 20.01.2026.

2. APP and advocates for the accused are present before the court. The envelop is opened before the Court in front of these advocates. After opening the envelop, it seems that there are so many documents and report of State Examiner of Documents in its original forms having 3 pages. It is of Outward No.NHP/36/2026/NHW/328/23/PPS, dated 16.01.2026. One plastic envelop having two diaries, one is small endorsed as N-18, 19 and 20 and another is a notebook mentioned as N-15, 16 and 17. Another envelop having total 5 original fixed deposit receipts of Nirmal Urban Cooperative Bank Ltd., Nagpur bearing No.51334, 35373, 51395, 51401, 51314. Two cheques of Nirmal Urban Cooperative Bank Ltd., Nagpur bearing No.127152, 127162 and one yellow receipt of Nirmal Urban Cooperative Bank Ltd., Nagpur bearing date 12.03.2018 and a demand promissory note in original form dated 12.03.2018, two applications given to the General Manager Nirmal Urban Cooperative Bank Ltd., Nagpur of Wasnik Yuvraj Natthu. Another documents of Nirmal Urban Cooperative Bank Ltd., Nagpur named as Saving Bank Account Opening Forms of Bombale Sachin Prakashrao dated 01.01.2018 along with it xerox copy of Aadhar Card and Pan card having original signature

marked as Exh.N-05, Kochankar Shailesh Bharatlal dated 03.10.2017 along with it xerox copy of Aadhar Card and Pan card having original signature marked as Exh.N-06, Wasnik Karuna Yuvraj dated 28.02.2018 along with it xerox copy of Aadhar Card and Pan card having original signature marked as Exh.N-07 and Wasnik Yuvraj Natthu dated 03.03.2018 along with it xerox copy of Aadhar Card and Pan card having original signature marked as Exh.N-08 and two diaries, one is mentioned as “जन सेवा के ५० से अधिक वर्ष नियोजक २०१० राष्ट्रीय बचत संस्थान वित्त मंत्रालय भारत सरकार” and Glaxoslepline Entroplus-2009 having name as Sachin Prakashrao Bombale in both the diaries. Two Panchanama of Handwriting, Signature and Number Sample dated 03.03.2023, Panchanama of Handwriting and Signature dated 26.06.2023 and another Panchanama of Handwriting, Signature and Number Sample dated 16.03.2023. Out of them, 3 panchanamas are of Crime No.294/2022 of Old Kamptee Police Station and 1 is of Crime No.21/2023 of Old Kamptee Police Station. Hence, Note taken below Exh.1.

3. APP is directed to supply the copies of these documents to both the accused and thereafter, these documents be kept in safe custody with Assistant Superintendent of this Court.
