**Order Below Exh. 39**

This is an application filed by accused No.1 namely Tauseef Iqbal Wakeel Ahmad for obtaining permission to go abroad. He is willing to go i.e. Saudi Arabia. He had applied for passport at Regional Passport Office. As per procedure passport authority called for character report from concern police station. It has come on record that present case is pending against the accused and for such reasons it is being difficult to proceed further. Hence this application.

2. Assistant Public Prosecutor opposed this application by filing say at Exh.41. According to prosecution serious offence is pending against the accused, if he permitted to go abroad there is possibility to abscond and could temper witnesses which may cause hurdle to decide the case. Finally prayed to reject the application.

3. Read application, say heard learned Advocate Shri. A.D.Bhimte for the accused and Assistant Public Prosecutor for State.

4. Record shows accused prosecuted for offences punishable under Section 279 of Indian Penal code and 184, 138/177 of Motor Vehicle Act. Said offence was registered as per report lodged by Sushil Jagdish Sunai under Section 279 of Indian Penal code and 184, 138/177 of Motor Vehicle Act.

5. After due investigation prosecution filed charge-sheet for offence punishable under Section 279 of Indian Penal code and 184, 138/177 of Motor Vehicle Act.

6. Hence, I am of the opinion that permission can be granted to accused to go abroad for the period of One year so that he could pray Hajj/Umrah for the year of 2026. Trial can be proceeded further in absence of accused by imposing certain conditions upon him. Hence I pass following order.

**ORDER**

1. Application is allowed. Permission is granted to go abroad with renewal of passport for the tenure of one year i.e. 10.04.2026 to 31.03.2027.
2. Applicant/accused No.1 namely Tauseef Iqbal Wakeel Ahmad is directed to furnish one surety of Rs. 50,000/- (Fifty Thousand Only) and file undertaking that if he fails to attend the court then he will deposit Rs.2,00,000/-(Two Lakh Only) in the court.
3. Application is disposed off.
