**ORDER BELOW EXH.01.**

This is an application for issuing heirship certificate under section 2 of the Bombay Regulation Act, 1827.

**02]** It is submitted by applicants that, applicant nos. 1 to 3 and 5 to 7 are grand sons, applicant no. 4 is daughter-in-law, applicant no.8 is son and applicant no.9 is a daughter of of Late Smt. Smt. Meerabai Somaji Ingole.

**03]** Late. Smt. Meerabai Somaji Ingole died intestate on 16.11.2011 at Chicholi, Khaparkheda, Tal. Saoner, Dist. Nagpur. Late. Smt. Meerabai Somaji Ingole was resident of Chicholi, Khaparkheda, Tal. Saoner Dist. Nagpur. The applicant nos. 1 to 9 have submitted that, except them there is no other legal heirs of Late. Chicholi, Khaparkheda. The applicants being legal heirs of Late. Chicholi, Khaparkheda, requires legal heirship certificate for judicial and quasi judicial work.

**04]** In support of this application, the applicant has submitted that, he has published citation notice and public notice in this petition. Citation notices are duly served as per **Exh.06**, public notice of petition was published in the local newspaper 'Lokmat Samachar' dated 28.01.2026 at **Exh.32**. The applicant has filed death certificate of Late. Smt. Meerabai Somaji Ingole at **Exh.19**, verified copy of Aadhar Card of applicant nos. 1 to 9 at **Exh.10** to **Exh.18**, death certificate and Aadhar card of Late. Shri. Sukhdevrao Somaji

Ingole at **Exh.20 and 21**, death certificate and Aadhar card of Late. Shri. Namdevrao Somaji Ingole at **Exh.22 and 23**, death certificate and Aadhar card of Late. Shri. Chhabitai Namdevrao Ingole at **Exh.24 and 25**, Letter issued by Grampanchayat Chicholi (Khaparkheda) at **Exh.26**, copy of Ration Card of Pushpabai Sukhdevrao Ingole at **Exh.27**, copy of Ration Card of Vasudev Somaji Ingole at **Exh.28**, copy of 7/12 extract of Survey No.19/41 at **Exh.29**, copy of leaving certificate of applicant No.6 at **Exh.30**, copy of leaving certificate of applicant No.1 at **Exh.31**. Nobody has raised objection in respect of grant of heirship certificate in the favour of applicants.

**05]** In support of this application, applicant has adduced his evidence on affidavit at **Exh.9**. He has deposed according to the application. All the documentary evidence corroborate with the oral evidence of applicant. Thus, the documentary evidence shows that, applicant nos. 1 to 9 are legal heirs of Late. Smt. Meerabai Somaji Ingole. Thus, they are entitled for grant of heirship certificate under section 2 of the Bombay Regulation Act. Hence, following order is passed.

### **ORDER**

- 01)** The application is allowed.
- 02)** Issue heirship certificate in the name of applicant nos. 1 to 9 as legal heirs of Late. Smt. Meerabai Somaji Ingole, as per rules.
